GENERAL INFORMATION

Milled Ammonium Sulfate with Antifoam is a formulation containing refined spray grade ammonium sulfate that is milled and blended with a proportionate amount of dry antifoam.

Ammonium sulfate had been approved as a tank mix additive to enhance the performance of many herbicides. Research with various crops and these herbicides has shown that weed kill has been increased when ammonium sulfate is used as an additive to the tank mix. Antifoam is designed to correct foaming issues created by herbicides (i.e. glyphosate) in tank mix solutions.


DIRECTIONS FOR USE AND MIXING

Only a small amount of Milled Ammonium Sulfate with Antifoam is added to the herbicide solution: 8 to 20 pounds per 100 gallons of water (1 to 2% v/v). Agitate the tank water while slowly adding the Milled Ammonium Sulfate with Antifoam. Allow enough time for complete dissolution before adding additional adjuvants or herbicides.

FOLLOW USE RATE DIRECTIONS ON HERBICIDE LABEL. THOROUGHLY RINSE EQUIPMENT AFTER USE.
